1. *PROMOTION DESCRIPTION.* The Red Hat Financial Services Developer Community of Practice Giveaway 2021 ("Promotion") is offered by Red Hat, Inc. as a way of rewarding members of the Red Hat Financial Services Developer community.
2. *TERM.* The Promotion will begin on March 11, 2021 at 8:00 a.m. Eastern Standard Time ("EST") and will run until December 31, 2021 at 11:59 p.m. EST ("Promotional Period").
