## **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED.

ENTRY IN THIS PROMOTION CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

1. **Eligibility**. 2. **Entry**. NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. The Promotion takes place between May 4, 2021 at 3:00 p.m. EDT and May 26, 2021 at 4:00 p.m. EDT ("Promotional Period"). To enter, Participant must visit <u>https://events.redhat.com/profile/374263</u> during the Promotional Period and fill out all required fields on the entry form ("Entry").

LIMIT - Participant may submit one (1) Entry for each Open Demo he/she attends. Subsequent Entries will be disgualified.
